



# 2010 Summer Preschool and School Age Day Camp Enrollment Form

Boulder Country Day (BCD) School's Summer Preschool and School Age Day Camp is open Monday June 7, 2010 through Friday, July 30, 2010. Day Camp hours are 8:00 a.m. – 4:00 p.m. (Note - Boulder Country Day's Summer Program is closed on July 2, 2010 and July 5, 2010.)

A \$25.00, non-refundable, administrative fee is required at the time of registration. This fee is applied per family – not child.

Summer Preschool and School Age Day Camp is billed monthly and due on the 1<sup>st</sup> day of each month. Before any student may attend the summer program, a BCD Summer Program Enrollment Form must be on file. A BCD Permissions Form and up-to-date emergency contact and medical/immunization information must also be on file.

The cost of BCD Summer Preschool and School Age Day Camps is as follows:

- Preschool = \$200.00/week (students ages 3-5) (Note - \$180.00/week for the weeks of June 28 – July 1, 2010 and July 6 – 9, 2010)
- School Age = \$170.00/week (students ages 6-13) (Note - \$150.00/week for the weeks of June 28 – July 1, 2010 and July 6 – 9, 2010)
- BCD will accept Preschool and School Age Day Camp students on a drop in basis if space is available. The rate for daily drop in Preschool or School Age Day Camp is \$50.00/day.

A \$100.00 tuition deposit for BCD Summer Preschool and School Age Day Camp is required. BCD gives registration priority to current BCD students. However, after March 1, 2010 the Preschool and School Age Day Camps will also be opened to the general public.

BCD requires one month notice - from the first date in which a child is registered to attend – to withdraw from our Summer Preschool and School Age Day Camp. If one month notice is not given prior to withdrawal, you will forfeit the \$100.00 tuition deposit and may be held liable for payment of the tuition for the time in which a student was registered to attend.

BCD Summer Preschool and School Age Day Camp tuition is separate from Summer Specialty Camp and Class fees. BCD Summer Specialty Camp and Class fees are listed in the 2010 Summer Specialty Camp Catalogue.

If a student who is registered for Preschool or School Age Day Camp also wishes to attend a Summer Specialty Camp, parents will not be billed for Preschool or School Age Day Camp tuition for time in which a child is in a Boulder Country Day Summer Specialty Camp or Class. However, if your child attends either BCD's Summer Preschool or School Age Day Camp before or after a specialty camp or class, hourly fees will apply and parents will be billed for time used. The cost of hourly Boulder Country Day Preschool and School Age Care is \$8.50 per hour, per child.

Children may not be left on school grounds unattended by a parent or guardian before or after Summer Day Camp hours. Late pick-up is strongly discouraged. BCD's Summer Preschool and School Age Day Camp dismisses daily at 4:00 p.m. Please note that beginning at 4:10 p.m., parents will be billed \$1.00 per minute, per child. Parents will be invoiced for late pick-up charges and payment is due upon invoice receipt. Consistently late pick-ups or payments may result in loss of your child's place in the Summer

Before any student may attend our Summer Day Camp, a BCD Summer Program Enrollment Form must be signed by a parent or guardian and on file. Current emergency contact information and medical/immunization information must also be on file.

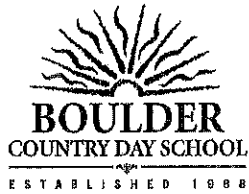

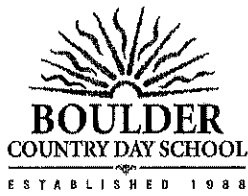
